The Client shall be liable to forfeit the non-refundable deposit of £1,500 + VAT should they decide not to attend the programme after booking, unless otherwise agreed between the Client and Ambur Associates, or should Ambur Associates be required to withdraw the offer as a result of the Client's instructions or lack of instructions, the inaccuracy of any Input Material or any other cause attributable to the Client.
4. The Client acknowledges that the time taken to complete the Services and the measure of their success depends in part on factors outside of the control of Ambur Associates. Any forecast or estimate made by Ambur Associates of the time for performance is given in good faith having regard to the information made available by the Client. Accordingly the Client agrees that it is reasonable that any such estimates and the confirmation or variation of them in subsequent reports and correspondence shall not be deemed in these circumstances to be undertakings, warranties or contractual conditions.
